TxDMV will not incur any penalty for late payment if payment is made in 30 days or less from receipt of goods or services and a correct invoice, which-ever is later.

As outlined in the SOW dated September 17, 2019 and as stated in letter from Explorer dated February 8, 2019:

Section 502.0024. The vendor will develop and implement programming for the Texas International Registration Plan (TxIRP) system to meet the requirements set by the Legislation for Extended Fleet Trailers HB1262. This system will allow an owner to register the vehicle for an extended registration period of not more than five years on trailers, semi-trailers, or pole trailers.

The owner will be given the opportunity to select one to five years to register the vehicle, but not more than five years.

Section 548.510 Fees required must be remitted to the comptroller for deposit in the Texas mobility fund, the general revenue fund and the clean air account. Fees shall be collected and remitted as prescribed by subchapter H.
