TxDMV pre-masked logo decals for fleet vehicles for installation by TxDMV staff.

These decals are intended for the installation onto TxDMV fleet vehicles and various department owned fleet equipment.

*Each pre-masked decal shall include a three (3) color Star logo (Blue, Green on White background), left text alignment along with the agency name in individual letters

The proposed Star logo is smaller than the existing design to accommodate for the added specifications below:

*Decal total length shall not exceed thirty-two (32) inches long.

*Installed by TxDMV staff and be in service for a period of more than ten (10) years, and

*Will be outside in the elements (e.g., UV light exposure, excessive heat, excessive cold, salt spray, rain, wind, repeated car washes/hand waxes).

*Printed text capital letter(s) shall be two (2) inches tall

The TxDMV Brand Guidelines manual is attached, which outlines requirements for logo reproduction.

Change orders will be allowed only if unforeseen conditions arise such as, but not limited to, increasing or decreasing quantities or if the department needs dictate changes. All changes shall be in the scope of original work. No verbal change orders shall be permitted. All change orders must be in writing with a Purchase Order Change Notice (POCN) issued by TxDMV Purchasing Section.

Payment:
