The background check shall include, but not be limited to, the following:

  - \* Department of Public Safety Statewide Criminal and Sex Offender Background Check
  - \* Background check in all Out-Of-State Counties in which the applicant has resided in the last seven (7) years.
- Persons with Class B Misdemeanor offenses shall not be allowed to work on this project and shall not be allowed access to the State documents.

Persons with Class A Misdemeanor offenses or above will be disqualified.

Service shall be performed in accordance with DIR's Exhibit A, Terms and Conditions.

**Change Orders:**

Change orders will be allowed only if unforeseen conditions arise such as, but not limited to, increasing or decreasing quantities or if the department needs dictate changes. All changes shall be in the scope of original work. No verbal change orders shall be permitted. All change orders must be in
