I. CONTRACTING PARTIES

This Amendment Number 3 to the Interagency Cooperation Contract, dated August 24, 2015 ("Contract") is made and entered into between:

- A. The PERFORMING AGENCY: The Texas Department of Criminal Justice (TDCJ), authorized by <u>Chapter 497, Government Code</u>.
- B. The RECIEVING AGENCY: The Texas Department of Motor Vehicles (TxDMV), an agency of the State of Texas authorized by <u>Chapter 504.006, Texas Transportation Code</u>.

II. AMENDMENT

It is mutually understood and agreed by and between the undersigned contracting parties to the Contract to amend said Contract as follows:

A. REVISE: Section III, Contract Payment, to read:

The total amount of this Contract shall not exceed **\$ \$25,354,513.87** and shall conform to the provisions of Attachment B, Budget.

B. REVISE: Attachment B to reflect the changes to Section III.

Attachment B is replaced in its entirety with the new Attachment B attached to this Amendment Number 3.

This Amendment Number 3 shall become effective when fully executed. All other terms and conditions of the Contract not hereby amended remain in full force and effect.

The undersigned parties do bind themselves to the faithful performance of this Amendment Number 3. This Amendment Number 3 may be executed in one or more counterparts, each of which is an original, and all of which constitute only one agreement between the parties.
