TWO STEP TIPS

90 Days to Inspect: Beginning March 1, 2016, you will have 90 days to complete the Two Steps. In order to register on time, your vehicle must pass inspection no earlier than 90 days before your registration expires.

Inspection Verification: If your vehicle passed inspection but the system is unable to electronically verify it, simply present your Vehicle Inspection Report (VIR), and you will be able to register.

Inspection Fees: The total inspection fee you pay has not changed. You pay the inspection station its portion of the fee at the time of inspection and the state's portion of the fee is collected at the time of registration.

eReminder: We will email you when it's time to inspect your vehicle and renew your registration once you sign up for eReminder at www.TxDMV.gov/eReminder.
