Moving interstate will require ELD's in commercial trucks effective December 2017. Moving intrastate Texas will require ELD's in mover's trucks effective December 16, 2019. Sgt. Moore will give a power point presentation, discuss the current hours of service rules which requires movers in Texas to keep driver's time on duty regardless of the size of the truck, not just CDL drivers. There are a few exemptions for the ELD's and Sgt. Moore will outline those, along with Q&A.
