

# PURPOSE AND EXECUTIVE SUMMARY

The Authority proposes to amend Title 43 Texas Administrative Code, Part 3, Chapter 57, by adding new §57.52, concerning the assessment of a penalty for late payment of fee or filing of report, and an appeal procedure. The new section is necessary to implement House Bill (HB) 3514 enacted during the 87<sup>th</sup> Legislature, Regular Session (2021).

#### FINANCIAL IMPACT

The department has determined that for each year of the first five years the new section will be in effect, there will be no significant fiscal impact to state or local governments as a result of the enforcement or administration of the new section.

#### BACKGROUND AND DISCUSSION

New §57.52 implements HB 3514 enacted by the 87<sup>th</sup> Legislature, Regular Session (2021). Transportation Code §1006.153, Fee Imposed on Insurers, provides "motor vehicle years of insurance" means the total number of years or portions of years during which a motor vehicle is covered by insurance. Insurers are required to pay to the MVCPA a fee equal to \$5 multiplied by the total number of motor vehicle years of insurance policies delivered, issued for delivery, or renewed by the insurer. New §57.52 provides that a penalty shall be imposed on an insurer for the delinquent payment of the required fee or the delinquent filing of the report of the fee that is required by rule. HB 3514 provides the MVCPA with the ability to audit or contract for the audit of fees paid under Transportation Code §1006.153(b-2) and requires the MVCPA to establish procedures by rule that provide a right to an appeal to an insurer assessed a penalty or interest under this section. The final decision regarding an insurer's appeal is decided by a majority vote of the MVCPA Board. The appeal of the assessment of a penalty of interest is not a contested case under Government Code, Chapter 2001.

#### PURPOSE AND EXECUTIVE SUMMARY

The Authority proposes to amend Title 43 Texas Administrative Code, Part 3, Chapter 57, §57.48, concerning motor vehicle years of insurance calculations.

The amendments are necessary to implement Senate Bill (SB) 224 enacted during the 88<sup>th</sup> Legislature, Regular Session (2023). SB 224 provides that the (a)(1) single statutory fee payable on each motor vehicle for which the insurer provides insurance coverage during the calendar year regardless of the number of policy renewals is increased from \$4 to \$5; and (a)(4) all motor vehicle or automobile insurance policies as defined by Insurance Code §5.01(e), covering a motor vehicle shall be assessed the \$5 fee.

#### FINANCIAL IMPACT

The department has determined that for each year of the first five years the new amendments will be in effect, there will be no significant fiscal impact to state or local governments as a result of the enforcement or administration of the amendments.

#### BACKGROUND AND DISCUSSION

Amendments to §57.48(a)(1) and (a)(4) implement SB 224 enacted by the 88<sup>th</sup> Legislature, Regular Session, 2023. Transportation Code §1006.153, Fee Imposed on Insurers, provides "motor vehicle years of insurance" means the total number of years or portions of years during which a motor vehicle is covered by insurance. Insurers are required to pay to the Authority a fee equal to \$5 multiplied by the total number of motor vehicle years of insurance policies delivered, issued for delivery, or renewed by the insurer.

Out of each fee collected under §1006.153, \$1 shall be deposited to the credit of the general revenue fund to be used only for coordinated regulatory and law enforcement activities intended to detect and prevent catalytic converter theft in this state. The money deposited to the credit of the general revenue may be appropriated to the authority for coordinated regulatory and law enforcement activities.

#### BACKGROUND AND DISCUSSION

HB 1, General Appropriations Act Eighty-Eighth Legislature appropriated the Texas Department of Motor Vehicles (TXDMV) \$24,189,100 in fiscal year 2024 for the MVCPA to pay TxDMV for administrative costs and to achieve the purposes of Texas Transportation Code Sec. 1006 to include:

- Providing financial support to law enforcement agencies for economic motor vehicle theft and fraud-related motor vehicle crime enforcement teams.
- Providing financial support to law enforcement agencies, local prosecutors, judicial agencies, and neighborhood, community, business, and nonprofit organizations for programs designed to reduce the incidence of economic motor vehicle theft and fraud-related motor vehicle crime.
- Conducting educational programs designed to inform motor vehicle owners of methods of preventing motor vehicle burglary or theft and fraud-related motor vehicle crime.
- Providing equipment, for experimental purposes, to assist motor vehicle owners in preventing motor vehicle burglary or theft.
- Establishing a uniform program to prevent stolen motor vehicles from entering Mexico.

Contingent on enactment of Senate Bill 224, the Eighty-eighth Legislature, Regular Session, appropriated TxDMV \$314,983 in fiscal year 2024 and \$279,386 in fiscal year 2025 from General Revenue and the Number of Full-Time-Equivalents in the agency's bill pattern is increased by 4.0 FTEs in each fiscal year of the 2024-25 biennium to implement the provisions of the legislation.

Also contingent on enactment of Senate Bill 224 by the Eighty-eighth Legislature, Regular Session, appropriated TxDMV, estimated to be, \$24,352,279 in fiscal year 2024 and \$30,099,417 in fiscal year 2025 for the purposes of coordinated regulatory and law enforcement activities intended to detect and prevent catalytic converter theft pursuant to Transportation Code, Section 1006.153(e).

# Proposed plan to review the records of persons regulated.

  - o Sale of multiple catalytic converters by one individual and or entity
  - Sale of catalytic converters involving multiple transactions over a period by individuals.
  - Failure to keep proper records of purchase or acquisition of catalytic converters.
  - Multiple violations of statutes and rules.

- MVCPA Analyst with the assistance of analysts from state agencies who regulate businesses involving the purchase, acquisition, sale, or transfer of catalytic converters perform a review of the records to identify suspicious activities and report the findings to MVCPA.
- In the beginning analysts should meet monthly as a group to discuss the results of their review and report to the MVCPA Director with recommendations for meeting frequency.

#### Proposed plan to respond to Suspicious Activities.

- Suspicious activities identified as suspected criminal violations forwarded to MVCPA Taskforce law enforcement personnel and TxDPS Criminal law enforcement for further investigation.
- Suspicious activities identified as suspected administrative violations forwarded to TDLR and TxDMV for inspection and follow-up.
- MVCPA shall track suspicious activities referred to state agencies and report to the MVCPA Board.

# In developing and implementing the plan, MVCPA shall focus on:

- Protecting each step in the legitimate stream of commerce that begins with the removal of a catalytic converter from a motor vehicle and includes recycling those catalytic converters to ensure that the persons regulated by the agencies listed are not the means for inserting stolen catalytic converters into the stream of commerce.
- Providing risk-based targeting and random auditing of the records of persons regulated by the agencies listed.

# Establishment of task force composed of persons regulated.

- MVCPA may establish a taskforce composed of persons regulated by the agencies listed who have substantial business experience in transactions involving catalytic converters. The authority shall develop the plan to review the records of persons regulated and respond to suspicious activities with the participation of the taskforce, if established.
- The authority may appoint members to the taskforce as the authority determines appropriate, except that persons regulated must be included in the taskforce composition.



# BACKGROUND AND DISCUSSION

ALPR equipment has become a non-intrusive tool for law enforcement who are investigating the theft of catalytic converters and associated motor vehicle crimes. The equipment captures the license plate number of vehicles operating in public places. The captured data includes time, date, and location of the vehicle and cross checks the license plate number with a stolen vehicle database. ALPR equipment only reads the license plate of a vehicle and cannot be used for facial recognition.

The captured data is stored in a database for a limited and customizable time before it is purged. This allows investigators to search the database with parameters provided by witnesses and victims for a particular area where the theft of catalytic converters has occurred, and vehicles have been stolen.

MVCPA Taskforce reports have identified that Catalytic Converter thieves are known to operate between the border regions of Laredo to the Rio Grande Valley and the Houston vicinity. The image displayed on the next page shows two phases to include Laredo, the Rio Grande Valley, Coastal Bend, and Houston as the priority for a network of ALPR cameras.

MVCPA operates the Grant Management and Tracking System (hereinafter referred to as GMTS) to meet its statutory obligations to: 1) provide financial support to law enforcement agencies for economic motor vehicle theft and fraud-related motor vehicle crime enforcement teams; 2) collect data to support the required education programs; and 3) meet legislative performance measures and reporting requirements. The objective of this grant from the Motor Vehicle Crime Prevention Authority ("MVCPA") to Texas A&M University ("TAMU") is to continue maintenance, operations and ongoing support of the existing grant management Software as a Service (SaaS) web application. Additionally, the MVCPA provides up to \$5,000 for deliverable based changes in programming or expansion of functionality that the MVCPA may request during the fiscal year. The grant is provided by MVCPA to TAMU in accordance with Transportation Code §1006.151.

#### Background

The MVCPA is a governor appointed board established in Transportation Code Chapter 1006. The MVCPA is administratively attached to the Texas Department of Motor Vehicles (TxDMV) and may only be provided personnel and various services by or through the TxDMV. MVCPA and staff will provide TAMU with updated Grant Administrative Manual and the Operations Guide including current forms and supporting documents that provide relevant business activities associated with the grant management and tracking.

#### TAMU Responsibilities

TAMU keeps the GMTS available on-line and operational to the grantees, MVCPA staff and board members.

TAMU will develop and maintain system protection to ensure business continuity processes for MVCPA in the event of a catastrophic occurrence. TAMU will provide a description of the business continuity and disaster recovery plan including backup protections that conforms to State of Texas law.

TAMU will make available a client friendly copy of the database including attachments if requested by TxDMV, MVCPA. The ability to provide a copy of the database including attachments will be tested annually to ensure capability and readability of the data. (*TAMU will ensure the database is ODBC compliant: Verify that the database to be moved is in a clean shutdown state. If the database isn't in a clean shutdown state, a soft recovery can be performed. Ensure all database mappings, type mappings, and the Integrity of the database is correctly intact*).

#### **Detailed Description of Requirements**

#### Training

The TAMU will provide training to MVCPA and grantee members (participants to be determined by TxDMV, MVCPA) at no cost to TxDMV.

TAMU will be invited and encouraged to attend monthly meetings with grantees to discuss Grant Management and Tracking System issues.

# Cost/Price, Agreement Type and Funding Years/Restrictions

This is a fixed price grant agreement in the amount of \$30,000.00 from September 1, 2023 through August 31, 2024. The MVCPA will pay \$7,500 each quarter after confirming that the deliverables are met. The deliverables and payment schedule are:

Each quarter the Grant Management and Tracking System (GMTS) is operational and being maintained. It is fully available on-line and regularly used by MVCPA staff and grantees. Reports are generated on-line with limited ad hoc reports provided. Data entry screens are available to MVCPA and grantees. The program staff at Texas A&M routinely and promptly respond to questions, needed fixes, and requests for assistance.

An additional \$5,000 is available to add or change functionality of the current GMTS. The process to add or change functionality will be provided by the MVCPA staff. TAMU staff will provide a price for the added or changed functionality with a payment and deliverable schedule. If the requested added or changed functionality is estimated to be \$5,000 or less then the MVCPA Director will provide an Amended Statement of Grant Award that adds the new payment and deliverable schedule.

If the requested added or changed functionality is estimated to be more than \$5,000, then TAMU will provide the full estimate. Only the MVCPA board may provide additional funds to the program. If approved an amended Statement of Grant Award may be provided after consideration by the MVCPA.

The MVCPA board may consider the additional work and provide an amended Statement of Grant Award to include the additional work if approved.

**Electronic and Information Resources Accessibility Standards-** All efforts will be made to ensure that the products operated under this Grant are accessible to TxDMV, MVCPA. TxDMV, MVCPA and TAMU will avoid complex graphics and material that undermine accessibility of the information contained in the GMTS.
