

# **PURPOSE AND EXECUTIVE SUMMARY**

Pursuant to Transportation Code, Section 1006.101, the Motor Vehicle Crime Prevention Authority, and the Texas Department of Motor Vehicles is required to submit an annual report on MVCPA operations to the offices of the Lieutenant Governor and Speaker of the House of Representatives.

# **BACKGROUND AND DISCUSSION**

Money appropriated to the department for authority purposes shall be used by the authority to pay the department for administrative costs and to achieve the statutorily required purposes, including:

- Providing financial support to law enforcement agencies for economic motor vehicle theft and fraud-related motor vehicle crime enforcement teams
- Providing financial support to law enforcement agencies, local prosecutors, judicial agencies, and neighborhood, community, business, and nonprofit organizations for programs designed to reduce the incidence of economic motor vehicle theft and fraud-related motor vehicle crime
- Conducting educational programs designed to inform motor vehicle owners of methods of preventing motor vehicle burglary or theft and fraud-related motor vehicle crime
- Providing equipment, for experimental purposes, to assist motor vehicle owners in preventing motor vehicle burglary or theft; and
- Establishing a uniform program to prevent stolen motor vehicles from entering Mexico.

MVCPA Grantees develop a plan to conduct activities to reduce motor vehicle crimes in their jurisdictions. Grantees are required to report the activities performed to the MVCPA in quarterly progress reports. The MVCPA reviews, monitors, and tracks the submitted performance data to develop a plan of operation and to report the operations and activities of the MVCPA to the Lieutenant Governor and Speaker of the House Representatives.

The FY22 Activity and Funds Report highlights the efforts of MVCPA and its grant funded taskforces in increasing the recovery rate of stolen motor vehicles, the clearance rate of motor vehicle burglaries and thefts, fraud-related motor vehicle crime, and the number of persons arrested for motor vehicle crimes.

Dear Honorable Lieutenant Governor Patrick and Honorable Speaker Phelan,

The Motor Vehicle Crime Prevention Authority (MVCPA or Authority) submits the following annual report, as required by statute, detailing the Authority's activities. This year marks the 30th anniversary of the first taskforce grants issued in 1993. The report shows that the dedicated investigators in MVCPA taskforces across the state continue to recover stolen vehicles, make arrests, and protect Texans and their property. The MVCPA is committed to continuing its operations and coordinating with other local, state, and federal agencies to ensure our borders are safer and that all available resources are used to address motor vehicle crimes throughout the state.

The MVCPA grants issued during the year supported specialized investigators, equipment, and statewide coordination to combat motor vehicle crime. The MVCPA taskforces continued to identify and address priorities of motor vehicle crime which included the theft of catalytic converters. During Fiscal Year 2022, the Harris County Sheriff's Office Auto Theft Taskforce suffered a tremendous loss when one of its own was killed while attempting to prevent the theft of a catalytic converter. MVCPA funding allowed multiple agencies in the Houston area to come together and work as a team to disrupt and shut down organized criminal organizations involved in catalytic converter crimes.

MVCPA taskforces maintained a presence in the state's ports and along the border to prevent stolen vehicles from being transported out of the State of Texas and from being utilized by the Cartels for illegal operations in Mexico including counterattacks against the Mexican military. The level of fraud used by criminal organizations to conceal the identity of stolen vehicles presents a challenge for officers to identify when vehicles may have altered vehicle identification numbers and other identifying labels. MVCPA funding allowed for the training of specialized investigators who have become experts in the identification of stolen vehicles and commercial motor vehicles being used for the transportation of illegal aliens, firearms, and drugs. These investigators use automatic license plate readers, conduct bridge and port inspections, and coordinate with other local, state, and federal law enforcement agencies to identify stolen and cloned vehicles used in the commission of crimes.

The MVCPA-related insurance fee generated \$110 million in state revenue for FY22, and the Authority appropriated \$14.9 million to ensure citizens receive a positive return to the insurance fees paid.

Thank you for your attention to this report and for the support you have shown the MVCPA program. I look forward to continuing working with you to ensure this valuable law enforcement enterprise performs as expected and has the resources needed to protect the citizens of Texas.

Created in 1991, the Motor Vehicle Crime Prevention Authority (MVCPA) has become an integral part of and an invaluable resource to Texas Law Enforcement. In 2023, MVCPA will celebrate the **30th anniversary** of the first grants issued in 1993.

The vision of the MVCPA is to empower local law enforcement agencies and communities to combat and prevent motor vehicle theft, motor vehicle burglary, and fraud related-motor vehicle crime so that all Texans will be free from harm and loss caused by these types of crime. Motor vehicle crime has real debilitating effects on people's lives. The losses of nearly 2 billion dollars each year is staggering. To combat these losses, MVCPA funded 24 law enforcement taskforces composed of 130 law enforcement agencies throughout the state. MVCPA also provided funding to 40 law enforcement agencies for the purchase or lease of Automatic License Plate Readers in 2022. This Fiscal Year (FY) 2022 activities and funds report was prepared to inform the Texas Legislature of the status of the MVCPA and of the efforts and activities of the statewide network to reduce motor vehicle crimes as required by statute (see Transportation Code §1006.101).

In FY22, the state collected \$110 million in fees from insurers. The Legislature appropriated \$14.98 million to MVCPA in the same year. This funding level represented 13.6% of the amount collected by the state and was below the 20%, or \$22 million, designated by Transportation Code §1006.153 (e). Not receiving the full statutory funding diminishes MVCPA's ability to support the growing needs of local police departments and sheriff's offices. Criminal organizations work to find new ways to prey on individuals, businesses, and government agencies. They adapt to changes in statutes, values of vehicles and parts, and government process. In FY22 the prices of catalytic converter components increased, and the theft of catalytic converters became a priority. Criminals have become more violent, especially when attempting to steal catalytic converters. The increase in violent crimes have resulted in the death of innocent victims and in one case the death of an MVCPA taskforce investigator trying to prevent the theft of a catalytic converter from his personal vehicle.

MVCPA funding allows local police departments and sheriff's offices to increase resources available in communities to work together in combatting statewide motor vehicle crime. The MVCPA grants provide for: salaries, specialized equipment, training to combat these crimes, ways to educate their citizens how to prevent these crimes, increased border security, and the tools necessary to prevent stolen vehicles from crossing international borders into Mexico or into other countries through seaports.

MVCPA has an agreement with TxDMV to separate the policymaking responsibilities of the authority and the management responsibilities of the department.

# **Identify Vehicles**

Motor vehicle crime investigators receive specialized training to identify motor vehicles and certain parts of motor vehicles.

Manufacturers of vehicles, trailers, equipment, and certain parts follow national and industry standards for marking and maintaining identification of their produced items. Records of these marks and identifications are maintained in databases managed by the National Insurance Crime Bureau. Properly credentialed and MVCPA trained law enforcement investigators use these databases to identify vehicles and to recover vehicles where criminals have

# Identify Prolific Offenders

Many motor vehicle crimes are committed by the same individuals or groups. These prolific offenders (3 or more arrests) are identified by taskforce investigators who spend time analyzing multiple streams of information. They review offense reports, witness statements, and intelligence briefings to identify these offenders.



El Paso Auto Theff Taskforce investigators responded to an Automatic License Plate Reader hit in an area where a repeat offender was known to reside. Through surveillance operations, the repeat offender was located and admitted to theft of the vehicle. Galveston Auto Theff Taskforce investigators assisted in a multi-agency pursuit of a stolen vehicle operated by a known prolific offender. The actor was arrested for multiple charges and investigators were able to clear numerous burglary cases.

# Fraud-related Motor Vehicle Crime

Fraud-related motor vehicle crime costs
Texans millions of dollars each year. One of
the costliest forms of fraud involves the
fraudulent sale of motor vehicles to innocent
purchasers. In this type of fraud, there are
often multiple victims. The first victim is the
person whose vehicle was stolen. The second
victim is a person who purchases a stolen
vehicle that has been represented as a
legitimate vehicle using fraudulent VIN
labels and a fraudulent Certificate of Title.
Criminals target the uninformed who may
not know the legal processes to purchase
and register vehicles. This type of fraud can
be debilitating to families.

When system weaknesses are identified and corrected to reduce fraud, criminals adapt and look for new methods to continue their fraudulent schemes. In one example of registration fraud where criminals were using fraudulent temporary buyer tags to avoid paying registration fees or hide the identity of a stolen vehicle, the Texas Department of Motor Vehicles cut off access to fraudulent dealers and added additional security features to temporary buyer tags. Criminals began stealing license plates from similar vehicles, creating fictitious metal plates, and using other technology to disguise the identity of a stolen vehicle or their own vehicle used to commit criminal activity.






# **BORDER SECURITY**

The MVCPA taskforces designated as border security grants collaborate with multiple agencies along the US-Mexico border and in the seaports. Taskforces work diligently to reduce the number of stolen motor vehicles being used for human trafficking and the smuggling of narcotics and weapons. This work includes surveillance operations, providing criminal intelligence briefings, identifying criminal actors, gangs and disrupting criminal enterprises.

Border Security taskforces routinely collaborate and conduct joint investigations with local, state, and federal agencies.

The Houston Auto Theff
Taskforce assisted US Customs
and Border Patrol in a joint
operation to identify and disrupt
narcotics trafficking, and identify,
apprehend, disrupt, and
intercept the movement of
weapons, ammunition, currency,
stolen vehicles, and stolen
property through the Area Port
of Houston. One suspect was
arrested for a Harris County
Family Violence warrant.

Laredo PD Auto Theff Taskforce routinely assists US Customs and Border Patrol at Border Checkpoints. In one case they responded to a checkpoint to assist with the identification of a truck tractor trailer. During the inspection, 70 illegal aliens were discovered, and the driver was arrested by Border Patrol.



# **EDUCATING THE PUBLIC**

MVCPA uses a variety of web-based tools to promote motor vehicle crime prevention efforts to the public. MVCPA frequently uploads motor vehicle crime prevention information on social media platforms – Facebook, Twitter, MVCPA TxDMV website, and links to taskforces across the state (commercials, YouTube videos, etc.) to remind the public to protect their vehicles.

## **Current Policies**

- Grant Administrative Manual Section 2.3.7.1 (Grant Budget Form)
  - Overtime is limited to 5% of the grant funded personnel salaries. For example, if total personnel costs are \$100,000 then MVCPA overtime is limited to \$5,000. The amount allowed may only be used for MVCPA funded or Cash Match personnel. For each position listed in the personnel section add a line in the overtime section and select the same subcategory. Enter in the estimated total amount of overtime that may be used for each grant program position. The amounts assigned for each line are estimates for the positions to help the applicant demonstrate the overtime. Actual overtime for each position may vary. The amount allowed may only be used for MVCPA funded or Cash Match personnel. For each position listed in the personnel section add a line in the overtime section and select the same subcategory. Enter in the estimated total amount of overtime that may be used for each grant program position. The amounts assigned for each line are estimates for the positions to help the applicant demonstrate the overtime. Actual overtime for each position may vary. #### RECOMMENDATION

Action Item. Recommend the MVCPA Director coordinate with the National Insurance Crime Bureau for the possible option of allowing MVCPA Taskforces to allow non-sworn and other trained personnel to perform confidential VIN inspections under the direct supervision of a law enforcement officer who is allowed to perform the confidential VIN inspections.

#### PURPOSE AND EXECUTIVE SUMMARY

Texas Transportation Code 501.0321(c) limits who can perform inspection and must have training by TxDMV rule (217.144). Inspections have only been performed by law enforcement officers. Subsection 2 allows a person working under the direct supervision of a law enforcement officer to perform confidential inspections.

## **BACKGROUND AND DISCUSSION**

An 96% increase in confidential VIN inspections since 2018 has created a challenge for MVCPA taskforces to keep up with increasing requests from citizens to obtain an inspection required to obtain a Texas Certificate of Title. Some taskforces have a backlog, and this creates a burden to citizens causing travel to other jurisdictions to obtain the necessary inspection to meet the titling and registration requirements.

Taskforces may have retired law enforcement officers, current law enforcement officers assigned to other divisions within their participating or coverage agency, citizens academy personnel, or other volunteers who have been properly vetted to assist their agency with confidential law enforcement functions.

Utilizing other personnel, who are properly trained, to work under the direct supervision of a law enforcement officer authorized to perform the confidential VIN inspections may increase the number of personnel available to perform the inspection and reduce backlogs for citizens while protecting the integrity and purpose of the confidential VIN inspections.

#### **BACKGROUND AND DISCUSSION**

The State Auditor's Office publicly released its audit on the Motor Vehicle Crime Prevention (MVCPA) at the Department of Motor Vehicles on March 3, 2023. The objectives of the audit were to determine whether MVCPA has processes in place to ensure that it:

- Awards, administers, and monitors its grants in accordance with applicable requirements.
- Complies with selected statutory requirements, including limitations on administrative expenses.

There was also one objective on the Department of Motor Vehicles' processes and controls related to ensuring the appropriate production and use of temporary vehicle tags.

The audit found that MVCPA had processes in place to ensure that it awarded, administered, and monitored grants in accordance with applicable requirements. MVCPA also had processes in place to ensure that it complied with certain statutory requirements for financial management, including limitations on administrative expenses. However, MVCPA should strengthen certain administration and monitoring processes to ensure that grantees use grant funds properly and that reimbursements are supported, reasonable, and allowable. Additionally, MVCPA should develop policies and procedures for its Grant Management and Tracking System.

The MVCPA Director coordinated with the Department of Motor Vehicles to provide a response to the recommendations detailed in the audit report. MVCPA agreed with the recommendations noted in the audit report and is committed to continuous improvement and transparency.

## **Grant Award Process**

The Motor Vehicle Crime Prevention Authority (Authority) established adequate processes for reviewing applications and awarding grants.

# **Grant Administration and Monitoring**

The Authority's grant administration and monitoring processes did not always ensure that grantees used grant funds properly and reimbursements were supported, reasonable, and allowable.

#### Recommendations

The Authority should develop and implement processes to ensure that:

- Grantees comply with cash match requirements as required by Authority policies and procedures and state rules.
- Grant adjustments are reviewed and approved in accordance with Authority's policies and procedures.
- Reimbursements made to grantees are supported, reasonable, and allowable.
- All grants are monitored in the GMTS.

#### Management's Response

The Authority agrees with the recommendations.

- The Authority will develop and implement processes to add stops to the Grant Management and Tracking System to ensure applications not meeting cash match requirements are submitted during the application or negotiation phase.
- The Authority will develop and implement processes to ensure grant adjustments are reviewed to ensure budget adjustments do not cause a violation of existing policies.
- The Authority has developed and implemented a thorough review process of applications and related expenditure reports to ensure reimbursements are reasonable and allowable.
- The Authority will identify and implement a solution for all grant types to be included in the Grant Monitoring and Tracking System. This solution will ensure automation and establish checks to indicate reports have been submitted, reviewed, and approved before grant payments can be issued. In addition, this solution will ensure all grants valued at \$25,000 are publicly posted.

# The Authority's Information Technology System

The Authority did not have information technology policies and procedures to ensure that Grant Management and Tracking System user access management, change management, or reviews of backup data recovery reports are performed effectively.

#### Recommendations

The Authority should coordinate with the Department to establish and implement policies and procedures related to user access, change management, and backup and recovery for its information technology systems.

#### Management's Response

- The Authority will develop and implement procedures and audit schedules to ensure all users accessing the Grant Monitoring and Tracking System are authorized.

## PURPOSE AND EXECUTIVE SUMMARY

To provide a briefing and update on Fiscal Years 2024 and 202 appropriations to the Texas Department of Motor Vehicles for the Motor Vehicle Crime Prevention Authority and legislative bills affecting the Authority and its grantees.

#### FINANCIAL IMPACT

In January 2023, the Texas House of Representatives and Senate filed their respective versions of the state's introduced budget bills, HB 1 and SB 1, respectively. Both introduced bills include identical levels of baseline funding for MVCPA totaling \$44.2 million for the biennium. This represents the full statutory funding for the program. The individual fiscal year amounts are \$21.9 million in FY 2024 and \$22.2 million in FY 2025. This will provide Unexpended Balance Authority within and between biennia which effectively gives the MVCPA board access to all funds without the need for a special fund.

## **BACKGROUND AND DISCUSSION**

Initial funding recommendations to the Texas Department of Motor Vehicles included full statutory funding for the MVCPA. Senate Bill 224 and House Bill 4598 would increase the MVCPA Fee from \$4.00 to \$5.00 to fund efforts to combat catalytic converter theft.
