INTRODUCTION TO VERSION 5.2.2 FIX 6

\$1 Organ Donor Fee Collection

Provisions for an option to collect a voluntary \$1 Organ Donor Fee when registering or renewing registration. This option will appear on the Fees Due (PMT 004) screen for all registration and title events with the exception of renewing via the Internet, RSPS, Special Plate system or the IRP system. The fee will appear on standard RTS reports, receipts, and screens. There should be no Organ Donor Fee collection without registration fee collection.

STEP	ACTION
1	After gaining the customers consent to collect the voluntary \$1 Organ Donor Fee, the user will place a check in the checkbox.
2	The fees description and item price will appear in the list box.

- There will be no provision for hot checks or refunds in RTS.
- The Organ Donor Fee is listed in the RTS Additional Collections/Time Lag and Regional Collection events to allow collection.
- The fee appears weekly on the county Funds Remittance Report (4604) and the regional office daily Funds Remittance Report (4604). The fees are held in a suspense fund by the Finance Division. The Finance Division will split and disperse the fee as follows: 10% Department of Human Services, 25% Department of Transportation, 03% Department of Public Safety, and 62% Comptroller of Public Accounts.

Disabled Parking Card Event Modification

To improve efficiency and inventory tracking in county offices, processing of all disabled person identification placards can now be processed through RTS. This event was modified giving additional options on the Disabled Parking Card (MRG002) screen to accommodate more selections. The selections are Blue Permanent Mobility, Blue Temporary Mobility, Red Permanent Non-Mobility, and Red Temporary Non-Mobility.

The Disabled Parking Card (MRG002) screen allows the option of issuing two placards during each transaction, charging \$5.00 for one placard and \$10.00 when the checkbox is checked for “Issue Two (2) Placards.” Notice the letter “I” was designated as a hot key. Relevant RTS screens, receipts and reports reflect accordingly. The expiration date displays only the month and year (i.e., 07/2009).


The Item Code Description will now identify items on all RTS inventory screens and reports providing identification of the listed items. The Item Code has been dropped on the following:





Title Only Enhancement

The system has been enhanced to facilitate the workaround necessary to process a Title Only transaction. The users will no longer select Exempt as the registration class or collect fees in the Additional Collections/Time Lag Event. A Title Only (No Regis) registration class is now available and fees will be collected in the Title Event.

Note: TONLY applications will no longer be sent to the Title Control Section (TCS) under separate cover with the **Title Package Report**.

STEP	ACTION
1	Process the Title Only transactions using the Title Application event.
2	The user will no longer select Exempt on the Class/Plate/Sticker Choice (REG008) screen during Title Only processing. The notation "Not For Title Only" was included as a reminder. 

STEP	ACTION
3	<p>Select Change Registration to access the Class/Plate/Sticker Type Choice (REG008) screen. The county should highlight/select Title Only (No Regis) in the Registration Class box as shown below.</p> 
4	<p>Use the mouse to click on the selection and the Plate Type field will automatically display Title Only (No Regis).</p>  <p>Select the ENTER key to continue</p>

STEP	ACTION
5	<p>The Title Record (TTL003) screen displays the selected class and type in the registration area.</p> 
6	<p>Select the ENTER key and the RTS000018 message appears, select the OK key to continue.</p> 
7	<p>The Title Event will collect all pertinent fees.</p>
8	<p>The Title Application Receipt prints showing the Plate No field vacant and Title Only (No Regis) appears in the Registration Class and Plate Type fields. The Sticker Type field is vacant.</p>
9	<p>Once the information arrives on the mainframe system:</p> <ul style="list-style-type: none"> • The system sets the plate number to TONLY plus the current month (i.e., TONLY08). • Selecting Title Only (No Regis) will set registration invalid. • The Reg Class Code is "99."
