

The Michigan Department of State is introducing a new certificate of title that incorporates a number of features for your convenience and protection. While its appearance is similar to the previous certificate, recent format changes offer a more user-friendly document while improving uniformity with titles from other jurisdictions. Additional security features provide heightened protection against document fraud, making it easier to detect tampering.

Some of the format changes include new locations for vehicle year, make, model and vehicle identification number. The odometer brand now has its own designation and other brands, such as "Salvage," "Flood" and "Municipal," are specifically placed under "Brand/Legend" on the front of the title.

Security features include:

- **Thermochromic Inks** – The back of each certificate contains two vertical stripes with images of the state of Michigan that are printed with thermochromic ink. When heat is applied to these areas (e.g. by the fingers or heat of a copier), the images disappear; once the area cools, the images reappear.
- **Microprinting** – The two rings encircling the Michigan coat of arms that make up the state seal on the front of the certificate are created by microprinting. With magnification of 8X or greater, the phrase "Michigan Department of State" in all capitals and without spaces between the words becomes evident.
- **Resistant Voids** – A warning stamp or mark of the word "void" in three languages is incorporated into the paper and becomes visible when any substances that dissolve ink, such as chlorine bleach, lighter fluid, rubbing alcohol or hydrogen peroxide, are applied.
- **Special Paper Coating** – The face of the certificate is treated with a special coating that adheres toner ink to the paper, making it difficult to remove or erase information printed by the Department of State.
- **Prismatic Printing** – The center "blue stripe" on the front and back of the document along with the green background are created through pantograph patterning. The green-to-blue-to-green variations are blended in such a way as to make copying or forging difficult.
- **Fluorescent Ink Watermarks** – Watermarks displaying the word "Michigan" and an outlined image of the state fluoresce on the front or back of the document when it is held under a black or ultraviolet light.
- **Color Photocopy Protection** – Attempts to duplicate or forge the title using a copier will result in the word "void" appearing on any copies.
- **Dual Image Numbering** – The consecutive control number on the front of the title is printed with special red-and-black ink. The front of the document shows the control number in black. When the back is viewed, a reversed, mirror image of the control number in pale red is seen.
